| <b>Inhalation:</b>       | Aspiration of product liquid into lungs is a risk and could lead to exogenous lipid pneumonia. Urgent Medical advice is required in suspected cases.   |
| <b>Ingestion:</b>        | Product is an Aspiration hazard and may be fatal if swallowed and enters airways. <b>Any breathing issue following ingestion requires urgent medical investigation.</b> Product may cause a mild transient laxative effect and discomfort. Even if only small amounts have been accidentally injected, this product can cause intense swelling and lipogranuloma formation, which may result in necrosis and even loss of a digit. Prompt surgical attention is required and may necessitate early incision and irrigation of the injected area, especially when there is involvement of the finger tissue or tendons.</p> <p>In very rare cases of ingesting the product there is the potential for exogenous lipid pneumonia due to the possibility of aspiration of the oil component of the product into the lungs. Ciliary clearance of product from the tracheobronchial tree is also disrupted by the mineral oil component.</p> <p>The product contains Thiomersal a recorded skin sensitiser with the NZ EPA, HAZ01001 vaccines containing between 0.005 – 0.1% Thiomersal content are considered hazardous under the HSNO Act.</p> |
